The filled in schedule will be received up to 3.00 PM and opened at 3.15 PM on the dates given above.
2. Separate requisition is required for issue of tender documents for each work with the required credentials.

The tender documents will be issued to the contractors those who have got registered their names either in TNPHC or PWD in the appropriate class and monetary limit, and they are requested to produce the latest registration copy issued either by PWD or in TNPHC registered as per the provision of the G.O.Ms.No:222 PWD (G2) dated 8.4.1999. Further, schedule will be issued only those who have got renewal certificate from TNPHC/registering authority and satisfactory performance certificate issued by the concerned Superintending Engineer for the works executed by them.

4. While seeking the tender documents, the tenderers are requested to produce the following documents duly attested for issue of tender documents.
  - a) Solvency certificate issued by Tahsildar with upto date Encumbrance certificate. The solvency for the respective classes should as per the limits fixed in the G.O. as stated in the para(3)
  - b) Current valid Income Tax Clearance certificate.
  - c) Current valid Sales Tax Clearance certificate (works contract tax)
  - d) Proof of registration under appropriate class with required monetary limit
  - e) Performance certificate in having work of building works/related works executed and completed. The evidence for the same should be produced from an officer of concerned organization not less than the rank of Superintending Engineer of Government (or) Government undertaking/responsible person of private organization.
5. Tamil Nadu Police Housing Corporation Ltd., will not be responsible for any delay be it postal/transitional.
6. Tenders received without EMD in proper form as specified in the tender schedule and unsealed tenders will be summarily rejected.
7. In case due date of tender happens to be holiday, the tender schedule will be received and opened on the succeeding working day without any change in the time indicated.
