2. The tender documents can be had from the office of the Superintending Engineer/North Circle, Tamil Nadu Police Housing Corporation Ltd. No. 55/1, Inspector quarters, (Near Police Hospital), TSP IInd Battalion campus, Avadi, Chennai – 600054 on requisition in writing in person on production of the prescribed cost by way of Pay Order/Demand Draft/Banker's Cheque drawn in favour of the Executive Engineer/Villupuram Division, Tamil Nadu Police Housing Corporation Ltd, DPO campus master plan complex, Villupuram 605602 payable at Villupuram (drawn from any one of the Nationalised Bank) on all working days between 10.30 A.M. and 1.30 P.M. on the dates mentioned against each work.  - b. Current valid Income Tax clearance certificate.
 - c. Current valid Sales Tax clearance certificate (works contract tax).
 - d. Proof of registration as contractor as stated above with required monetary limit and *registration with upto date renewal*.

All the envelopes duly sealed and super scribed with name of the work, reference number, due date of tender and name of the tenderer and addressed to Superintending Engineer/North Circle, Tamil Nadu Police Housing Corporation, No. 55/1, Inspector quarters, Near Police Hospital, TSP II Battalion campus,(Near Police Hospital) Avadi, Chennai – 600054.
