CONDITIONS FOR ISSUE OF TENDER DOCUMENTS :-

1. The tender documents can be had from the office of the Superintending Engineer/North Circle, Tamil Nadu Police Housing Corporation Ltd. No. 55/1, Inspector quarters, ,(Near Police Hospital), TSP IInd Battalion campus, Avadi, Chennai – 600054 on requisition in writing in person on production of the prescribed cost by way of Pay Order/Demand Draft/Banker's Cheque drawn in favour of the Executive Engineer/Villupuram Division, Tamil Nadu Police Housing Corporation Ltd, DPO campus master plan complex, Villupuram 605602 payable at Villupuram (drawn from any one of the Nationalised Bank) on all working days between 10.30 A.M. and 1.30 P.M. on the dates mentioned against each work. The filled in schedule will be received upto 3.00 P.M. and opened at 3.15 P.M. on the dates given above.
2. Separate requisition is required for issue of tender documents for each work with the required credentials.
3. The contractors those who have got registered their names in TNPHC Ltd (or) PWD in the appropriate class and monetary limit, are only eligible to participate in the tender and they are requested to produce the latest registration copy issued by the department concerned. The contractors those who have carried out such type of similar works are most preferable.
4. While seeking the tender schedules, the tenderers are requested to produce the following documents duly attested for issue of tender schedules (or) when the tender documents are downloaded at free of cost at website, the tenderer should enclose the following documents with tender schedule in "B" cover.
 - a. Solvency certificate issued by Tahsildar with up to date Encumbrance certificate.
 - b. Current valid Income Tax clearance certificate.
 - c. Current valid Sales Tax clearance certificate (works contract tax).
 - d. Proof of registration as contractor as stated above with required monetary limit and *registration with upto date renewal*.
 - e. Performance certificate in having satisfactorily executed and completed works of building works / related works (The completed value shall be more than 50 % of the value of the contract put to tender in a single contract) directly issued by the concerned organization during past five years. The evidence for the same should be produced from an officer not less than the rank of Superintending Engineer of Government or Government undertakings / responsible person of the private organization. In case of contractors who have executed works in TNPHC Ltd, the satisfactory performance certificate in the prescribed format from the Superintending Engineer concerned of TNPHC Ltd, should be furnished.
 - f. 5% working capital*
 - g. Performance certificate in prescribed format. The performance certificate in respect of private work should be supported with the enclosed format (Annexure – P) and the performance certificate should cover the works completed during the 5 previous financial years. In case of experience certificate for private works has been enclosed, it should cover in the certificate issued by IT Department indicating the head wise income and tax payable in addition to the Annexure 'P' enclosed. In the departmental PQ tender schedule.*
5. The tender should be accompanied by three separate envelope 'A' 'B' & 'C' duly superscribed on it the name of work, reference number and the due date of tender with name of the tenderer and sealed with the following particulars. Envelope 'A' should contain EMD in the form prescribed. Envelope 'B' should contain filled in Pre-Qualification schedules with the supporting documents. Envelope 'C' should contain filled in price schedule.

6. All the three envelopes each sealed separately should be enclosed in an overall envelope duly sealed and super scribed with name of the work, reference number, due date of tender and name of the tenderer and addressed to Superintending Engineer/North Circle, Tamil Nadu Police Housing Corporation, No. 55/1, Inspector quarters, Near Police Hospital, TSP II Battalion campus,(Near Police Hospital) Avadi, Chennai – 600054.
7. At the time and date notified above for opening, the overall envelope cover 'A' will be opened first. Envelope 'B' of those bidders who are satisfy the requirement of EMD only will be opened on the same day. If any bidders indicated the price in envelope 'A' & 'B' the bid will not be read out and will be rejected. The envelope 'C' of those who confirm to the Pre-Qualification requirement will be opened in the presence of those who choose to be present on a later date, time and place will be intimated to them well in advance.
8. *The monetary limit of pre-qualification tenders is above Rs.2.00 crores vide G.O.Ms.No.28 Public Works (G2) Department, dated : 01.02.2012.*

NOTE:

1. The Tamil Nadu Police Housing Corporation Ltd will not be responsible for any delay be it postal/transitional.
2. The tenders received without EMD in proper form as specified in the tender document and unsealed tenders will be summarily rejected.
3. In case due date of tender happens to be a holiday, the tender schedule will be received and opened on the succeeding working day without any change in the time indicated.
4. The undersigned reserves the right to reject any or all the tenders without assigning any reasons therefore.
5. The tenders received after due time and date will be summarily rejected and the telegraphic tender will not be entertained.
6. The tender documents will be issued only after verifying the credentials produced by the intending tenderers regarding previous performance, nature and value of work done and required Income Tax, Solvency, Sales Tax clearance etc.
7. Further the tender schedule for the above works can be down loaded from www.tenders.tn.gov.in at **free of cost** and submitted to the Superintending Engineer / North circle / TNPHC Ltd No. 55/1, Inspector quarters, ,(Near Police Hospital), TSP II Battalion campus, Avadi, Chennai – 600054 in person with the required credentials stated above and EMD in the prescribed format.

10. Price Adjustment Clause as per G.O.Ms.No.101 Public Works (G2) Dept, Dt : 10.06.2009 is applicable for the above works.
11. *“Contractors succeeded in the tenders should get their names registered in TNPHC Ltd in an appropriate class prior to execution of the agreement even though the contractors are registered in PWD”*

12. *The Contractors shall furnish the performance certificate of works should contain the details such as period of completion, Extension of time granted if any along with fine imposed if any.*
13. *The balance sheet are audited by their respective auditor's report should be certified by them stating that "the balance sheet is prepared based on the accounts maintained by the contractor and the same is audited by me".*
14. *The performance, quality of work, Character and integrity of the aspiring tenderers should be satisfactory. Also the contractor should have executed building / related works within the agreement period or Extension of time granted.*
