1. The tenderers are requested to upload the following documents duly attested when the tender documents are downloaded at free of cost at website, the tenderer should upload the following documents with tender schedule.
 - a. Revenue solvency certificate issued by Tahsildar with up to date Encumbrance certificate. The E.C should have been obtained after date of tender notice.
 - b. Current valid Income Tax clearance certificate.
 - c. Current valid Sales Tax clearance certificate (works contract tax).
 - d. Proof of registration of contractor as stated above with required monetary limit and **registration with upto date renewal**.
 - e. The performance Certificate in having satisfactorily executed and completed building works / related works (The completed value shall be more than 50% of the value of the contract put to tender in a single contract) directly issued by the concerned organization during past five years. (i.e. the works executed under sub-contract will not be considered for this purpose). The evidence for the same should be produced from an officer not less than the rank of the Superintending Engineer of the Government of Government undertakings / responsible person of the Private organizations.
