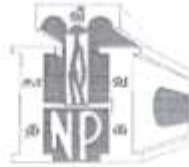

The filled bids will be submitted upto 3.00 P.M as per server time through online and opened at 3.15 P.M. on the dates given above. The bidders must possess **Digital Signature Certificate** for submission of bids through online in the above website.
2. The contractors those who have got registered their names in TNPHC Ltd., (or) PWD in the appropriate class and monetary limit, are only eligible to participate in the tender and they are requested to upload the upto date renewal registration (Scanned) copy issued by the department concerned. The contractors those who have carried out such type of similar works are the most preferable.
3. The tender schedule for the above works can be down loaded from www.tntenders.gov.in at free of cost and submitted to the Superintendent Engineer/North Circle, No.1&7, Inspector's quarters, PGR Line, Behind CPO Building, Annadhanapatty, Linemedu, Salem – 636 006 through online with the required credentials stated above and EMD in the prescribed format.
4. The tender notice is posted on TNPHC's Website viz., www.tnphc.com & www.tnpolice.gov.in to ensure speedy and wide coverage
5. Subsequent corrigendum/addendum if any shall only be available in web site indicated above.

The tenderers are requested to upload the following documents.

- a. Scanned copy of EMD.
- b. Scanned copy of Letter of Consent and Letter of Application.
- c. Scanned copy of the following credentials.
 - i) Copy of Registration as a contractor under Class-I (i.e. above Rs.75.00 Lakhs) in PWD or TNPHC with upto date renewal. (i.e., registration is valid on the date of tender.
 - ii) Experience certificate.
 - iii) Current Income tax returns.
 - iv) Current Sales tax verification certificate.
 - v) Revenue solvency for a value of Rs.30.00 Lakhs with upto date EC.
(i.e. the certificate should have been obtained after the date of tender notice).
- d. Digitally signed and filled tender coding sheet (BoQ – in excel format i.e. Booklet – 4) in addition to the digitally signed remaining three booklets in pdf format (totally 4 Booklets)

For PO tender in Serial No. 2

1. The tenderers are requested to upload the following documents duly attested when the tender documents are downloaded at free of cost at website, the tenderer should upload the following documents with tender schedule.
 - a. Scanned copy of EMD.
 - b. Scanned copy of Letter of Consent and Letter of Application.

- c. Revenue solvency certificate issued by Tahsildar with up to date Encumbrance certificate. The E.C should have been obtained after date of tender notice.
- d. Current valid Income Tax clearance certificate.
- e. Current valid Sales Tax clearance certificate (works contract tax).
- f. Proof of registration of contractor as stated above with required monetary limit and *registration with upto date renewal*.
- g. The performance Certificate in having satisfactorily completed as a prime contractor of Lift works in housing / Commercial (Ground + 6 Floors) under single agreement for a value ie., Rs.410.00 Lakhs in the last five financial years (2010-2011,2011-12, 2012-13,2013-14 & 2014-2015) in Tamilnadu police housing corporation Ltd. / Government department / Government undertaking / Public sector under taking . The performance certificate is to be obtained from the Engineers not below the rank of Superintending Engineer concerned or at equivalent level and the same should have been issued in India.
- h. The working capital available should be atleast 5% of the balance work on hand of all the works under execution by the contractor plus put to tender value of this work.
- i. The performance certificate in respect of private work should be supported with the annexure – 'P' (available in PQ document).
- j. The performance certificate should cover the works completed during the last five consecutive financial years.
- k. Affidavit should be furnished in 20 Rupees Stamp paper as per Annexure 'M' (available in PQ document)
- l. If any tenderer participates in more than one tender, he/they should substantiate his/their financial status and capability regarding management of labour and materials for all the works that he/they participates(s) in, supported with sufficient financial documents and experience certificates. The tender will be processed taking these aspects into account while preparing PQ evaluation statement.
- m. No tenderer is permitted to withdraw his/their tender at any stage. If any tenderer withdraws his/their offer within the tender validity period his/their EMD/SD shall be forfeited and his/their name(s) will be recommended for black listing.
- n. "The auditor's report" should be certified by the auditors stating that "the balance sheet is prepared based on the accounts maintained by the contractor and the same is audited by me". Further, the Chartered Accountant's membership Number should be clearly mentioned in their seal.
- o. The performance, quality of work, Character and integrity of the aspiring tenderers should be satisfactory. Also the contractor should have executed building/related works within the agreement period or extension of time granted.
- p. The balance sheet and Banker's Certificate for cash at Bank, un-utilized OD should be on the same date. The value given in the balance sheet for tools & plants and the certificate issued for tools and plants by the Chartered Accountant should be tallied.
- q. The amount received by the tenderer from the end users, incase of experience certificate for Private works has been enclosed by the tenderer, should cover in the certificate issued by IT department indicating the head wise income and tax payable in addition to the Annexure 'P' enclosed in the departmental pre-qualification tender schedule.
- r. The neat and clear copy of tender documents, other credentials required / specified in the tender shall be taken up for processing tender. Also any required clarification called for from the department shall be properly replied with supporting documents within the specified time. Failure on the part of the tenderer to comply with the requirements / clarifications sought for, the tender shall be decided on the merit of the case reserving the rights to reject the tender. (NPQ & PQ tender also).

2. The tender should be accompanied by two cover system 'A' & 'B' duly superscribed on it the name of work, reference number and the due date of tender with name of the tenderer with the following particulars. Cover 'A' should contain EMD in the form prescribed & should contain filled in Pre-Qualification schedules with the supporting documents. Cover 'B' should contain filled in price schedule. (BOQ for coding sheet)
3. All the two covers should be uploaded through online with the credentials.
4. *The monetary limit of pre-qualification tenders is above Rs.2.00 crores vide G.O.Ms.No.28 Public Works (G2) Department, dated : 01.02.2012.*
5. **For Lift tender in serial No.2. The tenderers should have the following credentials strictly.**
 - a. The applicant should remain in the same "name and style" with legal entity in India for the past "FIVE" years.
 - b. The applicant should be a reputed Lift manufacturing company having registered lift manufactures license and maintenance license from CEIG.
 - c. The applicant should produce "SARAL" as produced to Income Tax Department and details of Sales Tax Registration and the Sales Tax Verification Certificates that are obtained for the past "FIVE" financial years. (2010-2011,2011-12, 2012-13,2013-14 & 2014-2015).
 - d. The applicant should not have any of his contract terminated / rescinded due to breach of contract on part of the applicant during the past five financial years by any agency (2010-2011,2011-12, 2012-13,2013-14 & 2014-2015).
 - e. To get the contract , each bidder in its name should have the following credentials.
 - i. Average minimum annual financial turnover not less than Rs.1230.00 Lakhs during the last five year (2010-2011,2011-12, 2012-13,2013-14 & 2014-2015). The Annual turnover statement ie., Auditors report should be certified by the Chartered Accountant.
 - ii. Satisfactorily completed as a prime contractor of Lift works in housing / Commercial (Ground + 6 Floors) under single agreement for a value ie., Rs.410.00 Lakhs in the last five financial years (2010-2011,2011-12, 2012-13,2013-14 & 2014-2015) in Tamilnadu police housing corporation Ltd. / Government department / Government undertaking / Public sector under taking . The performance certificate is to be obtained from the Engineers not below the rank of Superintending Engineer concerned or at equivalent level and the same should have been issued in India.
 - iii. Liquid assets (ie., Cash at bank + unutilized O.D should not be less than a value of Rs.164.00 Lakhs .Necessary bankers certificate from Nationalised / Scheduled Bank should be furnished at the time of tendering.
 - iv. The tenderer should have full fledged service centre within a distance of 25 Kilometer from the site of work during and after sales and service period . The location of the service station should be stated with local phone number in the tender.
 - v. The tenderer should have a solvency of Rupees One Crore either Revenue department or Banker.

NOTE :-

No tenderer is permitted to withdraw his/her/their tender at any stage. If any tenderer withdraws his/her/their offer with in the tender validity period his/her/their EMD/SD shall be forfeited and his/her/their names (s) will be recommended for blacklisting.

Price Adjustment Clause as per G.O.Ms.No.101 Public Works (G2) Dept, Dt : 10.06.2009 is applicable for the works of steel & cement only
