The filled in schedule will be received upto 3.00 P.M. and opened at 3.15 P.M. on the dates given above.
- Separate requisition is required for issue of tender documents for each work with the required credentials.
- The contractors those who have got registered their names in TNPHC Ltd (or) PWD in the appropriate class and monetary limit, are only eligible to participate in the tender and they are requested to produce the latest registration copy issued by the department concerned.   - Current valid Income Tax clearance certificate.
  - Current valid Sales Tax clearance certificate (works contract tax).
  - Proof of registration as contractor as stated above with required monetary limit and **registration with upto date renewal**.
  - Performance certificate in having satisfactorily executed and completed works of building works / related works.
  - The contractor should submit the TDS certificate issued by the Income Tax Department and not by the Auditors.
