CONDITIONS FOR ISSUE OF TENDER DOCUMENTS :-

1. The tender documents can be had from the office of the Superintending Engineer/CC, Tamil Nadu Police Housing Corporation Ltd.No. 132, E.V.R. Salai, (Poonamallee High Road), Near G-3 Police Station, Kilpauk, Chennai – 600 010 on requisition in writing in person on production of the prescribed cost by way of Pay Order/Demand Draft/Banker's Cheque drawn in favour of the Executive Engineer / Chennai Division-I. Tamil Nadu Police Housing Corporation Ltd, No. 132, E.V.R. Salai, (Poonamallee High Road), Near G-3 Police Station, Kilpauk, Chennai – 600 010 (drawn from any one of the Nationalised Bank) on all working days between 10.30 A.M. and 1.30 P.M. on the dates mentioned against each work. The filled in schedule will be received upto 3.00 P.M. and opened at 3.15 P.M. on the dates mentioned above.
2. Separate requisition is required for issue of tender documents for each work with the required credentials.
3. The bidder should be executed and completed the similar nature of work in the specificfield.
4. While seeking the tender schedules, the tenderers are requested to produce the following documents duly attested for issue of tender schedules (or) when the tender documents are downloaded at free of cost at website, the tenderer should enclose the following documents with tender schedule.
 - a. Revenue / Banker Solvency certificate for Rs.50.00 lakhs and above issued by the competent authority.
 - b. Current valid Income Tax clearance certificate.
 - c. Current valid Sales Tax clearance certificate (works contract tax).
 - d. Encumbrance certificate (upto date).
 - e. Firm registration certificate.
5. Performance certificate in having satisfactorily executed and completed the similar nature of works in the specificfield. (The completed value for a value of Rs.500 lakhs in a single contract directly issued by the concerned origination during past five years. The evidence for the same should be produced from an officer not less than the rank of Superintending Engineer of Government or Government undertakings / responsible person of the private organisation. In case of contractors who have executed works in TNPSC Ltd, the satisfactory performance certificate in the prescribed format from the Superintending Engineer concerned of TNPSC Ltd, should be furnished.
6. ***The monetary limit of pre-qualification tenders is above Rs.2.00 crores vide G.O.Ms.No.28 Public Works (G2) Department, dated : 01.02.2012***
7. All the envelopes duly sealed and super scribed with name of the work, reference number, due date of tender and name of the tenderer and addressed to Superintending Engineer / Chennai Circle, Tamil Nadu Police Housing Corporation Limited, No.132, E.V.R. Salai, Kilpauk, Chennai – 600 010.

8a. For Lift tender in serial No.1. The tenderers should have the following credentials strictly.

1. The applicant should remain in the same “name and style” with legal entity in India for the past “FIVE” years.
2. The applicant should be a reputed Lift manufacturing company having registered lift manufactures license and maintenance license from CEIG.
3. The applicant should produce “SARAL” as produced to Income Tax Department and details of Sales Tax Registration and the Sales Tax Verification Certificates that are obtained for the past “FIVE” financial years. (2011-12, 2012-13, 2013-14, 2014-15 & 2015-16).
4. The applicant should not have any of his contract terminated / rescinded due to breach of contract on part of the applicant during the past five financial years by any agency (2011-12, 2012-13, 2013-14, 2014-15 & 2015-16).
5. To get the contract, each bidder in its name should have the following credentials.
 - (a) Average Minimum annual financial turnover not less than Rs.1500.00 Lakhs during the last five year (2011-12, 2012-13, 2013-14, 2014-15 & 2015-16). The Annual Turn over statement i.e., Auditors Report should be certified by the Chartered Accountant.
 - (b).Satisfactorily completed as a prime contractor of Lift works in housing / Commercial (Ground+2 floors) under single agreement for a value ie Rs.500.00 Lakhs in the last five financial years (2011-12, 2012-13, 2013-14, 2014-15 & 2015-16) in Tamil Nadu Police Housing Corporation Limited / Government Department / Government undertaking / Public Sector undertaking . The performance certificate is to be obtained from the Engineers not below the rank of the Superintending Engineer concerned or at equivalent level and the same should have been issued in India.
 - (c) Liquid assets (i.e cash at bank + unutilized O.D.) should not be less than a value of Rs.200.00 Lakhs. Necessary bankers Certificate from Nationalised / Scheduled Bank should be furnished at the time of tendering.
 - (d).The tenderer should have full-fledged service centre within a distance of 25 Kilometer from the site of work during and after sales and service period. The location of the service station should be stated with local phone number in the tender.
 - (e) The tenderer should have a solvency of Rupees 50 Lakhs either Revenue department or Banker.

NOTE:

1. The Tamil Nadu Police Housing Corporation Ltd will not be responsible for any delay be it postal/transitional.
2. The tenders received without EMD in proper form as specified in the tender document and unsealed tenders will be summarily rejected.
3. In case due date of tender happens to be a holiday, the tender schedule will be received and opened on the succeeding working day without any change in the time indicated.
4. The undersigned reserves the right to reject any or all the tenders without assigning any reasons therefor.
5. The tenders received after due time and date will be summarily rejected and the telegraphic tender will not be entertained.
6. The tender documents will be issued only after verifying the credentials produced by the intending tenderers regarding previous performance, nature and value of work done and required Income Tax, Solvency, Sales Tax clearance etc.
7. Further the tender schedule for the above works submitted to the Superintending Engineer / Chennai circle / TNPSC Ltd , Kilpauk, Ch – 10 in person with the required credentials stated above and EMD in the prescribed format.

8. The tender notice is posted on TNPHC'S Website viz., www.tnphc.com & www.tnphc.gov.in to ensure speedy and wide coverage
9. *No tenderer is permitted to withdraw his/her/their tender at any stage. If any tenderer withdraws his/her/their offer with in the tender validity period his / her / their EMD/ SD shall be forfeited and his/her/their names (s) will be recommended for blacklisting.*
10. *"Contractors succeeded in the tenders should get their names registered in TNPHC Ltd in an appropriate class prior to execution of the agreement even though the contractors are registered in PWD"*
11. *In addition to the regular registered contractors the tenderers of the reputed firms those who are doing typical nature of work and proven track record on these fields may also participate in the tenders should enclose the evidence of the past performances along with their tender.*
12. *The Contractor shall furnish the performance certificate of works should contain the details such as value of work, value of executed work period of completion, Extension of time granted if any along with fine imposed if any.*


