2. The contractors those who have got registered their names in TNPHC Ltd( or ) PWD in the appropriate class and monetary limit, are only eligible to participate in the tender and they are requested to upload the upto date renewal registration ( scanned ) copy issued by the department concerned. The contractors those who have carried out such type of similar works are the most preferable.
3. The tenderers are requested to upload the following documents duly attested when the tender documents are downloaded at free of cost at website, the tenderer should upload the following documents with tender schedule.
  - a. Revenue Solvency certificate issued by Tahsildar with up to date Encumbrance certificate should have been obtained after date of tender notice.
  - b. Current valid Income Tax clearance certificate.
  - c. Current valid Sales Tax clearance certificate (works contract tax).
  - d. Proof of registration of contractor as stated above with required monetary limit and **registration with upto date renewal**.
  - e. Performance certificate in having satisfactorily executed and completed works of building works / related works.

4. The tender should be accompanied by single cover system duly superscribed on it the name of work, reference number and the due date of tender with name of the tenderer.

4. The performance, quality of work, character and integrity of the aspiring tenderers should be satisfactory. Also the contractor should have executed building/related works within the agreement period or extension of time granted.
