The filled in schedule will be received upto 3.00 P.M. and opened at 3.15 P.M. on the dates given above.
- Separate requisition is required for issue of tender documents for each work with the required credentials.
- The contractors those who have got registered their names in TNPHC Ltd (or) PWD in the appropriate class and monetary limit, are only eligible to participate in the tender and they are requested to produce the latest registration copy issued by the department concerned. The contractors those who have carried out such type of similar works are most preferable.
- While seeking the tender schedules, the tenderers are requested to produce the following documents duly attested for issue of tender schedules (or) when the tender documents are downloaded at free of cost at website the tenderer should enclose the following documents with tender schedule in "B" cover.
  - Solvency certificate issued by Tahsildar with up to date Encumbrance certificate.
  - Current valid Income Tax certificate.
  - Current valid Sales Tax clearance certificate (works contract tax).
  - Proof of registration as contractor as stated above with required monetary limit and **registration with upto date renewal**.
  - Performance certificate in having satisfactorily executed and completed works of building works / related works.
  - The contractor should submit the TDS certificate issued by the Income Tax Department and not by the Auditors.
- All the envelopes duly sealed and super scribed with name of the work, reference number, due date of tender and name of the tenderer and addressed to Superintending Engineer/North Circle, Tamil Nadu Police Housing Corporation, No.1&7, Inspector's quarters, PGR Line, Behind CPO Building, Annadhanapatty, Linemedu, Salem – 636 006.
