No.1&7, Inspector's quarters, PGR Line, Behind CPO Building, Annadhanapatty, Linemedu, Salem – 636 006 on requisition in writing in person on production of the prescribed cost by way of Pay Order/Demand Draft/Banker's Cheque drawn in favour of the Executive Engineer/Salem Division, Tamil Nadu Police Housing Corporation Ltd, Annadhanapatti Police Station Campus, Salem – 636 002 payable at Salem (drawn from any one of the Nationalised Bank) on all working days between 10.30 A.M. and 5.45 P.M. on the dates mentioned against each work. The filled in schedule will be received upto 11.00 A.M. and opened at 11.15 A.M. on the dates given above.
2. Separate requisition is required for issue of tender documents for each work with the required credentials.
3. **The Tenderer / Manufactures / Suppliers** those who have got registered their names in **Tamil Nadu Energy Development Agency**, are only eligible to participate in the tender and they are requested to produce the latest registration copy issued by the department concerned and live certificate. The bidder those who have carried out such type of similar works are most preferable.
4. While seeking the tender schedules, the tenderers are requested to produce the following documents duly attested for issue of tender schedules (or) when the tender documents are downloaded at free of cost at website, the tenderer should enclose the following documents with tender schedule.
  - a. Revenue Solvency certificate issued by Tahsildar with up to date Encumbrance certificate (i.e., the certificate should have been obtained after the date of tender notice).
  - b. Current valid Income Tax certificate.
  - c. Current valid Sales Tax verification certificate (works contract tax).
  - d. Proof of registration with TNEDA and live certificate.
  - e. Performance certificate in having satisfactorily executed and completed works in similar nature for works completed 6 month before tender notice date.
  - f. The contractor should submit the TDS certificate issued by the Income Tax Department and not by the Auditors.
