Tamil Nadu Police Housing Corporation Ltd, No. 132, E.V.R. Salai, (Poonamallee High Road), Near G-3 Police Station, Kilpauk, Chennai 600 010 (drawn from any one of the Nationalised Bank) on all working days between 10.30 A.M. and 1.30 P.M. on the dates mentioned against each work. The filled in schedule will be received upto 3.00 P.M. and opened at 3.15 P.M. on the dates given above.
- 2. Separate requisition is required for issue of tender documents for each work with the required credentials.
- 3. The contractors those who have got registered their names in TNPHC Ltd (or) PWD in the appropriate class and monetary limit, are only eligible to participate in the tender and they are requested to produce the latest registration copy issued by the department concerned.

  - b. Current valid Income Tax returns certificate.
  - c. Current valid Sales Tax verification certificate (works contract tax).
  - d. GST Registration Certificate.
  - e. Proof of registration as contractor as stated above with required monetary limit and registration with upto date renewal.
  - f. Performance certificate in having satisfactorily executed and completed works of building works / related works.
  - g. The contractor should submit the TDS certificate issued by the Income Tax Department and not by the Auditors.
  - h. Banker solvency certificate for not less than the value of Rs.25.00 Lakhs should be produced for Manufactures / Reputed dealers of this specific nature for Sl.No.1
  - i. Registration with upto date EC (i.e., Encumbrance Certificate should have been obtained from the Sub-registrar office after the date of tender notice for the period from the date of solvency certificate)
