2. The tenderer should submit the original EMD scrip (The scanned copy of the scrip which has been uploaded in his/their tender) to the tender opening authority during opening of the tender. Otherwise his/their tender will be liable for rejection.  
Note : There should not be any variations/correction to the EMD scrip furnished in the tender and physically handed over in person.
3. The contractors those who have got registered their names in TNPHC Ltd., (or) PWD in the appropriate class and monetary limit, are only eligible to participate in the tender and they are requested to upload the upto date renewal registration (Scanned) copy issued by the department concerned. The contractors those who have carried out such type of similar works are the most preferable.

(i.e., registration is valid on the date of tender). If the registration is in the name of "FIRM" copy of Partnership deed and copy of Registration of Firm (Form C) should be uploaded.
  - ii) GST Registration Certificate.
  - iii) Experience certificate.

- iv) Current Income tax returns.
- v) Current Sales tax verification certificate (Work contract tax).
- vi) Proof of incorporation certificate issued by Registrar of companies.
- vii) Proof for individual/Proprietorship, Partnership deed/Act, Private Limited Company/Companies, Articles of Memorandum.
- viii) Revenue solvency for not less than the value of Rs.30.00 Lakhs for I Class and Rs.22.50 Lakhs for II Class according to the class of Registration with upto date EC. (i.e. Encumbrance Certificate should have been obtained from the Sub-registrar office after the date of tender notice for the period from the date of solvency.
- ix) Digitally signed and filled tender coding sheet (BOQ – in excel format i.e. Booklet – 4) in addition to the digitally signed remaining three booklets in pdf format (totally 4 Booklets)
