CONDITIONS :-

The bidders must possess Digital Signature Certificate for submission of bids through online in the above website. Tenderers shall submit their tender in electronic format on above mentioned website after digitally signed the same. Tenders which are not digitally signed will not be accepted.

- The tenderer should submit the original EMD scrip (The scanned copy of the scrip which has been uploaded in his/their tender) to the tender opening authority during opening of the tender. Otherwise his/their tender will be liable for rejection.
 - Note: There should not be any variations/correction to the EMD scrip furnished in the tender and physically handed over in person.
- 3. The contractors those who have got registered their names in TNPHC Ltd., (or) PWD in the appropriate class and monetary limit, are only eligible to participate in the tender and they are requested to upload the upto date renewal registration (Scanned) copy issued by the department concerned. The contractors those who have carried out such type of similar works are the most preferable.
- The tender schedule for the above works can be down loaded from <u>www.tntenders.gov.in</u> at free of cost and submitted to the Superintending Engineer/North Circle, No.1&7, Inspector's quarters, PGR Line, Behind CPO Building, Annadhanapatty, Linemedu, Salem – 636 006 through online with the required credentials stated above and EMD in the prescribed format.

- 7. The undersigned reserves the right to reject any or all bids without assigning any reasons therefore.

The tenderers are requested to upload the following documents.

- c. Scanned copy of the following credentials.
 - i) Copy of Registration as a contractor under Class-I (i.e above Rs.75 lakhs) & Class -II (i.e. above Rs.30.00 Lakhs) in PWD or TNPHC with upto date renewal. (i.e., registration is valid on the date of tender). If the registration is in the name of "FIRM" copy of Partnership deed and copy of Registration of Firm (Form C) should be uploaded.
 - ii) GST Registration Certificate.
 - iii) Experience certificate.
 - iv) Current Income tax returns.
 - v) Current Sales tax verification certificate (Work contract tax).
 - vi) Proof of incorporation certificate issued by Registrar of companies.
 - vii) Proof for individual/Proprietorship, Partnership deed/Act, Private Limited Company/Companies, Articles of Memorandum.

- viii) Revenue solvency for not less than the value of Rs.30.00 Lakhs for I Class and Rs.22.50 Lakhs for II Class according to the class of Registration with upto date EC. (i.e. Encumbrance Certificate should have been obtained from the Sub-registrar office after the date of tender notice for the period from the date of solvency).
- ix) Digitally signed and filled tender coding sheet (BOQ in excel format i.e. Booklet 4) in addition to the digitally signed remaining three booklets in pdf format (totally 4 Booklets).
- x) Incase the tender is made by an individual, the tender documents shall be signed by the individual with his name and address and submit along with a copy of (duly attested by Notary Public / Gazatted Officer) proper contractor registration certificate.
- xi) Incase the tender is made by a registered firm, it shall be signed by the Managing Partner (or) the person authorized by the firm, with full name of the firm and address. The proof shall be submitted along with the copy of partnership deed and firm registration. (Copies should be duly attested by Notary / Gazatted Officer).
- xii) Incase the tender is made by a limited company or a limited corporation, it shall be signed by a duly authorized person holding the power of attorney for signing the tender in which case a certified copy of the power of attorney shall accompany the tender. The Articles of Memorandum of the Company and profile of the company with company incorporation certificate copies with seal (duly attested by Notary / Gazatted Officer) shall be submitted along with his / their tender.
- xiii) Incase a tenderer, tendered in the Name and Style of Proprietorship concern the tenderer should have registered his firm name in the respective registrar office and enclose the copy of Proprietorship Deed (duly attested by the Notary / Gazatted Officer) along with the tender.

NOTE :-

The tenderer should be registered with GST.

The total value of a contract which exceeds Rs.2.50 Lakhs, 2% GST Tax at source will be deducted.

No tenderer is permitted to withdraw his/her/teir tender at any stage. If any tenderer withdraws his/her/their offer within the tender validity period his/her/their EMD/SD shall be forfeited and his/her/their names (s) will be recommended for blacklisting.

"Contractors succeeded in the tenders should get their names registered in TNPHC Ltd in an appropriate class prior to execution of the agreement even though the contractors are registered in PWD".

The contractor shall furnish the performance certificate of works should contain the details such as period of completion, Extension of time granted if any along with fine impoxed if any.

The performance certificate in respect of private works should be supported along with TDS Statement (Le. Form 16A & Form 26AS).

Credentials of the tender(s) for the work executed by htm/them in the past 5 years supported by certificate. The date of completion of the works stated in the experience certificate should be within the past 5 years prior to the date of lender.
