The Performance certificate in respect of private works should be supported along with TDS statement(i.e. Form 16A & Form 26AS) Credentials of the tenderer(s) for the works executed by him/her/them in the past five years supported by the certificates issued by the authority not lower than the rank of Superintending Engineer should be furnished. The date of completion of the works stated in the experience certificate should be within the past 5 years prior to the date of tender.
